<i>Credit:</i>	2 hours taken on an S/U basis
<i>Offering:</i>	Fall semester, Spring and Summer Semesters
<i>Prerequisites:</i>	1. ECON 201 OR ECON 212 2. ECON 220
<i>Availability:</i>	Open only to economics majors and minors

Please note that this course does not count as an Economics elective for the Econ major or minor

Procedure and Requirements:

- (1)** Discuss the internship with your economics advisor (or with the Director of Undergraduate Studies/ Undergraduate Program Coordinator). Complete form on Page 2. *The Econ Department may refuse to sign if the internship is not relevant to the study of economics.*
- (2)** Upon approval, return completed form to the Undergraduate Program Coordinator (email econungrad@emory.edu or Rich Building 319) who will enroll you in the course or give you a permission number you will use to enroll (on an S/U basis).
- (3)** All of the above must be completed before the start of or during the internship. The term in which you enroll must coincide at least partially with your employment duration. Economics 449 *cannot* be applied retroactively.
- (4)** You must write a three-page, double-spaced report discussing how the internship experience related to your economic training and in what ways it helped your professional development. You may draw on the textbook listed below. You must submit this report to the Undergraduate Program Coordinator (econungrad@emory.edu) **no later than the last day of classes** in the semester in which you are taking the internship. *A grade of U will be assigned to those who do not turn in their report on time; no exceptions will be made.*
